

Summary of 2019/20 Central Florida (Ridge) and Indian River-Southwest Florida Citrus Custom Rate Charges

This report presents the results of a survey conducted by mail during December 2019 among Florida citrus caretaking companies to collect data on their custom rate charges during the 2019/20 season. Cooperatives, their members, and growers performing their own cultural practices were not included in the survey. Therefore, this report refers to grove practices that growers may contract out. The custom rates for growers who are members of such cooperatives or the costs for growers who conduct their own cultural practices may differ from the rates reported below.

Eighteen caretakers participated in the survey this season, giving a response rate of 42%. From the total number of participants, five were citrus caretakers and service providers from Central Florida (Ridge), three were from the Indian River, and four were from the Southwest Florida region. The remainder six caretakers serviced two or three regions, and the data they provided was used for both reported regions. Participants represented 81,785 acres, which accounts for approximately 19% of the total citrus acreage in Florida (USDA-NASS, 2020).

The average custom rate charges for the Central and the combined Indian River and Southwest Florida regions are presented in Tables 1 and 2, respectively. Tables are organized by program; each with an itemized list of grove practices. The tables also include the minimum and maximum rates reported for each practice.
